Xtend Barre Southside & Eastside Membership Terms & Conditions

MEMBERSHIP options:

- VIX: Unlimited Classes per month, \$185 per month;
- Elite: 8 Classes per Month, \$140 per month; or
- Essentials: 4 Classes per Month, \$72.00 per month.

Contract Agreement: Between client and Xtend Barre Southside & Eastside for classes per chosen membership (as above) in one month in exchange for monthly fee direct debited automatically by Ezidebit.

Contract Duration and Automatic Renewal: Contract is in force from the contract start date, with automatic renewal for subsequent months, unless cancelled by either the client or Xtend Barre Southside & Eastside, with notification of 30 days in advance of the next billing date.

Agreement to Pay Recurring Fees: The client agrees to pay Xtend Barre Southside & Eastside monthly recurring fees as as per the above fee structure via client's authorised credit card including cancellation payments (if applicable) associated with the contract.

Terms & Conditions:

1. I agree to purchase the Membership as selected above as an automatic charge to my credit card each month for a minimum of 2 months (taking into account the 30 day termination policy).
2. I hereby certify that I am the holder of the credit card account associated with this membership.
3. I understand that if a debit is returned by my/our financial institution as unpaid, a failed payment fee is payable by me/us to Ezidebit as per DDR Service agreement. This fee is \$9.90
4. I understand that Xtend Barre Southside & Eastside have the right to terminate my contract should my account become more than 30 days late.
5. I agree in order to cancel my autopay, a completed termination request form must be submitted in writing at least 30 days in advance of the next billing date in order for my request to be effective from the following month. Billing date is based on my activation date. This request can be either emailed to southside@xtendbarre.com or eastside@xtendbarre.com or submitted in person at Reception.
6. I agree in order to freeze my auto pay, a completed request form must be submitted in writing at least 14 days in advance of my requested account suspension. Billing date is based on my activation date (unless prior freezes have been actioned). I understand I can freeze my auto pay schedule for free up to three times per calendar year for a minimum period of 1 week (seven days) per freeze. Subsequent freezes will incur a \$25 processing fee. Following the end of my freeze period, my monthly auto-renew will automatically be reactivated. NB: This may change my billing date. Suspensions/freezes must be requested in writing to southside@xtendbarre.com or eastside@xtendbarre.com or may be submitted in person to Reception.

7. All fees are non-refundable and non-transferable.
8. I acknowledge 10 hours notice of cancellation is required for all classes. No shows or cancellations within the 10 hour time frame will either result in a \$15 charge to my credit card (VIX members) or will result in a forfeiture of that class from my pass (Elite or Essentials members). Please note that cancellations will not be accepted via email or telephone, these must be done online.
9. I understand that minimum numbers are required in order for classes to proceed, meaning classes may be cancelled by Xtend Barre Southside & Eastside should those minimum numbers not be met.
10. I understand the class timetable may be changed at any point in time at the discretion of Xtend Barre Southside & Eastside.
11. I understand that this authorisation will remain in effect until I cancel the Membership Agreement and/or authorisation in writing and in accordance with the above terms, and I agree to notify the studio in writing of any changes in my Credit Card details at least 15 days prior to the next billing date. In the case of a transaction being rejected, I understand that Xtend Barre Southside and Eastside may at it's discretion attempt to process the charge again within 30 days. I certify that I am an authorised user of this credit card and will not dispute these scheduled transactions with my financial institution, so long as the transactions correspond to the terms and conditions indicated in this authorisation form.
